San Luis Obispo is a mountainous county along the Pacific ocean on the central coast of California between Los Angeles and San Francisco.

In 2000, the median age was about 4 years older than California. One of every 7 people was 65 years or older, and one in 56 was 85 or older. Nearly one in 4 adults was 65+ or disabled.

Unemployment was low at 2.8% (2001). There were estimated to be 349 direct care nursing staff needed in facilities (2000). Average hourly wages (2001):

In San Luis Obispo County, one in every 12 persons was Medi-Cal eligible. One in every 100 persons in the county was 65+ and a Medi-Cal recipient.

The median home price was \$258,861 (2001). Compared to California, housing vacancy rates in 2000 were lower: homeowners at 1.1% and rentals at 3.2%.

San Luis Obispo had more households with individuals 65+ (24.6%) and with those 65+ living alone (10.3%) than California. Of those over 65, one in 2.6 was living alone (38.3%).

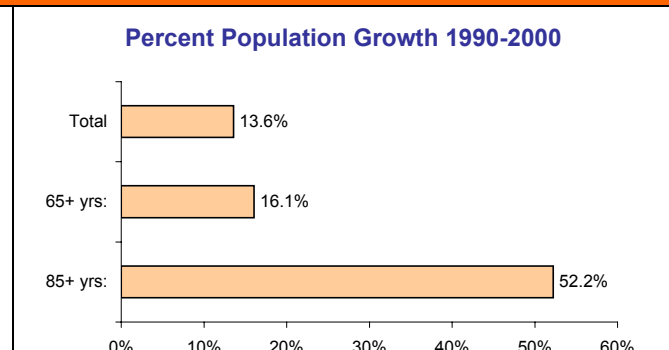

Demographic Trends

In the last decade, San Luis Obispo County's population grew at a slower pace than California. However, there was a slightly faster rate of growth in both the 65+ and 85+ population.

In 2000, San Luis Obispo had 24% non-Whites, while California had 53% non-Whites. One of every 6 persons in the county was Hispanic/Latino; one in 38 was Asian; one in every 45 persons was multi-racial; and one in 53 was Black/African American. Looking at age and ethnicity: one in 7 persons was 65+/White; one in 149 was 65+/Hispanic/Latino; and one in 435 was 65+/Asian.

The median household income was \$5,000 less than California's with fewer people living below the poverty level--one in 8.
