



## ADULT DAY PROGRAM (ADP) - 2012 Membership Dues Categories

ADP centers are licensed by the California Department of Social Services Community Care Licensing Division.

- Membership is for an existing center or for a center site yet to be determined. Membership "applicant name" is the center name.
- Licensees with multiple adult day services centers must bring ALL centers into GROUP membership, completing an application for each.
- GROUP memberships are eligible for a dues discount based on the combined actual gross revenue of ALL centers in the Group.

### Membership Classifications *(Categories, Dues and Benefits information is available for each)*

☞ Adult Day Program (ADP) Membership: Pre-licensed | New Licensee / Ownership | Licensed

☞ Adult Day Health Care (ADHC) Membership: Pre-licensed | Newly Licensed/New Ownership | Licensed

☞ Associate (ASOC) Membership: Consultant | Vendor | Allied/Government Organization | Corporate Office

*Associate membership is not permitted for those with an ownership or employment (administrator / program director) relationship with one or more adult day services centers unless ALL such adult day services centers are in membership with CAADS.*

☞ CAADS reserves the right to classify applicants according to the appropriate membership category ☞

### PRE-LICENSED ADP | Non-Voting | Annual Dues \$250

Individual / business considering, or in the process of applying for ADP licensure with the California Department of Social Services Community Care Licensing Division. Membership in this category is granted for up to 3 membership years or until licensure, whichever is sooner.

*Those who already own/operate a licensed adult day services center are ineligible for Pre-Licensed membership unless all their licensed centers are in membership with CAADS.*

### NEW LICENSEE / OWNERSHIP ADP | Voting | Annual Dues Based on Year 1, 2, 3 of Licensure / Ownership

ADP center licensed less than 4 years with California Department of Social Services Community Care Licensing Division. Membership in this category is granted for a maximum of 3 membership years.

Year 1 New Licensee / Ownership: \$ 600 Annual Dues Rate

Year 2 New Licensee / Ownership: \$ 1,000 Annual Dues Rate or 50% of Licensed Rate based on actual gross revenue, *whichever is less*

Year 3 New Licensee / Ownership: \$ 1,500 Annual Dues Rate or 50% of Licensed Rate based on actual gross revenue, *whichever is less*

### LICENSED ADP | Voting | Annual Dues Based on Actual Gross Revenue for Most Recent Fiscal Year End

ADP center currently licensed by California Department of Social Services Community Care Licensing Division.

***A licensee operating more than one center is required to place ALL centers into membership as a GROUP.***

*ADPs operating within an ADHC license must pay dues according CAADS ADHC Membership Dues Rate Schedule.*

**DISCOUNT Dues Rate for GROUP selecting COMBINED Revenue Method\* entitled to:**

One voting representative designated on behalf of the group of adult day services centers.

One representative from each center in Group designated to receive CAADS' communications, and otherwise entitled to full membership privileges.

*\*Annual dues rate is based on the most recent fiscal year end total combined actual gross revenue of ALL centers in Group.*

**REGULAR Dues Rate for GROUP selecting SEPARATE Revenue Method\* entitled to:**

One voting representative designated for each and every adult day services center in Group.

One representative from each center in Group designated to receive CAADS' communications, and entitled to full membership privileges.

*\*Annual dues rate is based on separate actual gross revenue for each and every adult day services center (ADHC and/or ADP) in Group*

### CAADS Membership Year is January 1 through December 31. New Members Pay Prorated Dues.
